

TERMINAX PPF GIVEAWAY

1. Eligibility

This giveaway is open to legal residents of the United States and Canada (excluding residents of Quebec) who are 18 years of age or older and represent a registered automotive dealership or authorized distributor that attends a confirmed TERMINAX appointment at SEMA 2025 in Las Vegas, Nevada.

Only one (1) entry per business is permitted. Employees, contractors, representatives, and immediate family members of TERMINAX, its affiliates, subsidiaries, advertising or promotional agencies, and anyone involved in the administration of this giveaway are not eligible to participate.

Void where prohibited or restricted by law.

2. Entering the Giveaway

Eligible participants will receive one (1) entry form after completing a confirmed appointment with TERMINAX at SEMA 2025.

Each entry form must include:

- First and Last Name
- Business Name
- Business Address
- Phone Number
- Instagram Handle

Entries must be dropped into the official TERMINAX Giveaway Box located at the TERMINAX booth before the close of the event on **Friday, November 7, 2025**. The box will remain sealed except for the entry slot and visible to the public. Limit one entry per business.

3. No Purchase Necessary

No purchase or payment is required to enter or win. Making a purchase or conducting business with TERMINAX will not increase chances of winning.

4. Winner Selection

The drawing will take place during the final hour of SEMA 2025 on Friday afternoon.

To ensure fairness:

- The giveaway box will be thoroughly mixed before the draw.

- Three TERMINAX team members will each be blindfolded and draw one entry.
- The drawing will be streamed live on Instagram (@terminax.global).
- The first draw determines Winner #1, the second Winner #2, and the third Winner #3.
- A non-participating representative will read the selected form aloud and show it on-screen for verification.

Canadian Entrants: To comply with Canadian law, each potential Canadian winner must correctly answer a time-limited, skill-testing mathematical question before being confirmed as a winner.

5. Transparency

The Instagram Live broadcast will remain publicly viewable for at least 30 days following the event. A recap post listing the winners' business names and states/provinces will be published on the official TERMINAX website and Instagram. All entry forms will be securely stored for 30 days, then destroyed.

6. Odds of Winning

Odds of winning depend on the total number of eligible entries received.

7. Winner Notification and Verification

Winners will be notified within forty-eight (48) hours using the contact information provided. Winners must respond within ten (10) calendar days and complete all required verification, including signing the Prize Acceptance and Publicity Release forms.
